Turn left at the stop sign onto Lake Emily Road. Camp Bandy is on the left shortly after crossing under the Hwy 10 overpass.

- > BITCHES IN SEASON may be tested as the last dog(s) at the end of the day.
- Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of Event Hosts.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event hosts, be asked to leave the event site. In such a case, no refund of event fees paid shall be made.
- Owners and their Agents are solely responsible for the presence of their dog(s) at the Test arena. Judges are not required to wait for dogs.
